

We greatly appreciate your continued support of the AOCD, especially during this crazy time.






Fall 2020 app metrics












Guidelines:

February 12, 2021 is the cutoff date for submitting abstracts to the AOCD office.

Abstracts will be no more than 400 words. A one page PDF will be emailed to (jwise@aocd.org) along with a submission fee of \$500 per abstract. Posters and abstracts will be viewed via our meeting app.







